2. Owner agrees to pay training rate \$700 plus board of \$4 per day will be paid at the end of the training period. Feed will include free choice prairie hay, 7lbs of alfalfa pellets, 3.5lbs of a custom blended Bent E Quarter Horses feed, and 3.5lbs dry weight of soaked Standlee Smart pulp (Beat Pulp). Both alfalfa and custom blend are both milled by the Bartlett COOP in Bartlett KS.
3. All horses will be kept in 40x90 paddock with shelter for animals.
4. If owner wishes to supply feed it must be of a high quality feed and must bring with them at time of dropping off said horse with at least 1 50lb bag of feed per week
5. Owner is responsible for paying for any and all of the following if required
  - a. Wormer – If horse is at facility longer then 6 weeks
  - b. Show fees
  - c. Farrier services – Nolen Richie, or Joe Tignanelli
  - d. Veterinary Services – Dr, Hailey Mueller Veterinary Services LLC, Dr, Katelyn Eike of Outlaw Equine (Lameness)
6. Horses in general will be worked on a 5 day schedule Monday - Friday for 4 weeks. If weather dose not permit horses to be work due to weather owner is responsible for paying board to give both Bent E QH safe working conditions to provide the best outcome.
7. If owner has preferred local Veterinarian and farrier please list name and phone numbers. If no preferred Veterinarians or Farriers are preferred then Bent E QH will use ones listed above. Owner will be notified before any cost from 5 is incurred
